



## REQUEST FOR NOMINATIONS: NYSFAH 2019 AWARDS FOR EXCELLENCE

At the *NYSFAH Awards for Excellence Reception* in New York City on **November 14, 2019** we will honor special achievement in affordable housing development over the previous year. NYSFAH members are encouraged to make nominations in the following categories:

- **Advocate of the Year:** Nominees should be individuals who have had a particularly strong positive impact on the field of affordable housing development, either locally or state-wide. Preference will be given to the unsung heroes of affordable housing, including those in government.
- **Non-Profit of the Year:** Nominees should be not-for-profit organizations that have demonstrated excellence in either the development of affordable housing or the delivery of services to residents.
- **M/WBE of the Year:** Nominees are M/WBE entities that have demonstrated excellence in either providing contractual services for development purposes or are developers themselves. Certification is not necessary for consideration, but evidence of ownership is required for those entities that are not certified with the city or state.

*Nominations for the above three categories must consist of a narrative of no more than 250 words expressing the nominator's reasoning for including the candidate for nomination. Back up documentation may also be provided.*

- **Projects of the Year (Upstate/Downstate):** Awards will be presented to the developer / project partners recognizing excellence in one or more of the following categories: community need, capacity to catalyze economic development in the surrounding neighborhood, financing, affordability, design, construction techniques, and energy efficiency. **Separate awards will be given to upstate and downstate projects.** The project must have been completed and **placed in service prior to November 14, 2019.** **All project nominations must include this form, budget analysis, development narrative, and photographs at the time of submission to [elizabeth@nysafah.org](mailto:elizabeth@nysafah.org)**

NYSFAH supports sustainability efforts, creativity in design and financing and innovation in services provided given the limited public resources available. Unique development and sustainable features will be heavily considered in the determination of project awards. Please provide a narrative describing your sustainability efforts, creative design work and innovative financing tools that you would like the committee to consider when determining development efforts – such as but not limited to, project location, type of construction, and population served. All submissions **MUST** include a narrative addressing any high cost drivers and efficiency efforts which may also be a consideration in assessing final award determinations.

**Please complete the nomination form and submit it with any attachments no later than October 28th to [elizabeth@nysafah.org](mailto:elizabeth@nysafah.org). Award recipients will be selected by NYSFAH's Awards Committee and will be notified by October 30th.** Members may nominate themselves or other members; feel free to nominate a project in which you are a participant or hold a financial interest. You may make separate nominations in more than one category.

*Please keep in mind as you prepare your nominations that NYSFAH is interested in recognizing individuals and projects large and small across New York State. NYSFAH reserves the right to assign nominees to different categories.*
